

The Challenge:

Bio-NEST NIPER Guwahati announces **Prototype-to-Product Demo Challenge** to encourage and support innovative ideas in the field of sciences and healthcare. Interested candidates shall submit their innovative ideas for participation in the **Prototype-to-Product Demo Challenge**.

The Scope of Challenge:

 The scope includes innovation related to any Med-Tech, Bio-Energy, Waste Management, Biotechnology, Bio-Services, Pharmaceuticals, Nutraceuticals, Natural Ingredients, Traditional/Ayurvedic systems, Herbs processing & export, Herbal Medicine/Phytopharmaceuticals, Agriculture/Medicinal Plants, etc. or closely related fields

The Award:

- Top 5 prototypes will be awarded prize money of INR **10,000**; **9,000**; **7,500**; **6000**; **5,000** respectively.
- The top 5 winners will be provided pre-incubation support for six months and a pre-incubation support fund of INR **90,000** with the following breakup:
- a) Fellowship: INR 2,500/month (Total: INR 15,000)
- b) Rental of Incubation Center: INR 2,500/month (Total: INR 15,000)
- c) Consumables from NIPER Guwahati: up to INR 35,000
- d) Instrument user charges: up to INR 8,000
- e) Mentorship charges: up to INR 7,000
- f) Operational/Legal/Compliance Support (e.g., Company Formation): up to INR 10,000
- If, for any reason, the Individual/team decides to discontinue the project, then all the unutilized assets should be returned to NIPER Guwahati with immediate effect.

Eligibility Criteria:

- The **Prototype-to-Product Demo Challenge** is open to all, irrespective of their qualification, affiliation, gender, geographical location, and educational background.
- The applicant must have a working prototype/ product sample/ clearly defined R&D concept ready for productization.
- The applicants may apply as an individual, team of individuals, business entity or as a society.

- When applying as a group, business entity or a society, the project must identify a project leader among them, for further interactions with NIPER Guwahati.
- If selected, applicants should be willing to commit to physical incubation at BioNEST NIPER Guwahati and utilize the facilities and infrastructure at the incubation centre.

Application Process:

Bio-NEST NIPER Guwahati will launch the program on 07th August 2025 on the NIPER Guwahati website.

- The call for proposals will close on 22nd of August 2025 at 23:59.
- The applicant needs to fill out the Google form link attached to the Prototype-to-Product Demo Challenge flyer.
- Applicants are advised to submit their applications early without waiting for the last date to avoid any last-minute contingencies.
- Applicants are advised to provide sufficient details in their applications to allow for an informed and fair evaluation/review.
- Applicants are advised to provide self-contained proposals with essential supporting materials along with the application form.
- Proposals once submitted are final. No changes will be accepted thereafter
- Providing incorrect information will lead to outright rejection of proposals.

Selection Process:

- As an initial step, all proposals will be reviewed by an expert committee to assess their compliance with the eligibility criteria.
- Those eligible candidates for the **Prototype-to-Product Demo Challenge** will be invited for a physical presentation and will be assessed by the jury members.
- The basic evaluation parameters are i) Technical feasibility, ii) Novelty, iii) Commercialization Potential, iv) Societal Impact, v) Business Plan, vi) Depth of R&D.
- The jury may also add other parameters to evaluate and rank applicants during the course of the challenge.
- Based on the reports by the jury, the winners shall be selected for the prize and seed fund.

Important Dates:

- Proposal submission opens: 07th Aug 2025.
- Last date for submission: 22nd August 2025
- Evaluation and shortlisting of applications: Tentatively 22nd August 2025.
- Pitching round of shortlisted proposals: Tentatively 25th August 2025.

- The selected applicants for Pre-Incubation Support shall sign a separate agreement with NIPER Guwahati for initiating their works as incubatee of Bio-NEST.
