Job involves not only placing purchase orders but also involves responsibilities like receipt of materials, and their preservation, Maintenance of stock ledgers, Issue of materials, Gate passes, handling Disposals, Maintenance of instruments, equipment's and other related services arranging payments to suppliers etc. Person recruited is also expected to handle Imports and should have through knowledge in establishing letter of credits, arranging foreign payments, handling import clearances, and capable of making correspondence with suppliers through emails etc. The knowledge of operating the computers is an essential requirement.

- 7. On recommendation of the Screening/Selection Committee, the Competent Authority may relax the experience of the candidates in exceptionally meritorious cases.
