### 1. EXPRESSION OF INTEREST

Empanelment of IP Firms for handling NIPER-G's IP application and s any other IP-related work assigned from time to time by the institute.

The National Institute of Pharmaceutical Education and Research Guwahati (NIPER-G) is a national-level institute in pharmaceutical sciences with a proclaimed objective of becoming a centre of excellence for advanced studies and research in pharmaceutical sciences. The Government of India has declared NIPER as an 'Institute of National Importance'. It is an autonomous body set up under the aegis of the Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, Government of India. The Institute is conceived to provide leadership in pharmaceutical sciences and related areas within the country and to the countries in South East Asia, South Asia and Africa. NIPER is a member of the Association of Indian Universities and the Association of Commonwealth Universities.

As a part of Academic and Continued research and development going in the institute, its Faculty, Technical officers, Research scholars, and Ph.D. scholars are developing new ideas and technologies which may ultimately lead to the patenting of innovation. To Assist the Institute in handling such kind of work, the institute is looking for a highly reputed agency in the field with the required experience, expertise, infrastructure and with proven performance for shortlisting their name.

Expression of Interest (EOI) is requested for the empanelment of IP firms that are in the field for handling NIPER-G's Indian and foreign patent-related applications and for securing and safeguarding protection for other forms of IP in India and Abroad. The applying firms and their counterpart foreign associates should be able to provide services for:

- Filing, prosecution, maintenance, opposition, litigation, revocation, restoration, and any other proceedings in respect of foreign patent applications/patents and for registration/securing of other forms of IP in India and abroad.
- All other forms of IP and related work comprising services for copyright matters, design, trademark, layout design, plant varieties, opposition, litigation, revocation, restoration, representation before the Appellate Board in India, miscellaneous actions under the relevant Act and any other proceedings in India.
- Other IP-related work comprising drafting agreements, MOU, Freedom to operate searches, assistance in licensing, and other IP Management matters like IP audit, IP valuation, commercialisation strategy, and opinion/advice relating to IP matters.
- Providing support in case of challenges.

The IP firm should have good standing for at least a period of five years or more. The firm must have filed patent applications for more than 100 inventions in India and abroad (including PCT applications) for clients based in India (Out of which at least five should be Central/ State government funded Universities/ Research Institutes). The IP firm should possess professional expertise, especially in handling patent applications in the field of Drug/Pharmaceutical, Chemical, Biological, and Engineering. The firm must have the requisite infrastructure and be financially sound. It should have offices with easy access to Guwahati and an established network of leading foreign attorney firms worldwide that can handle the assigned work concerning NIPER-G's patent applications and other forms of IP.

The 'Techno-legal IP bid' is invited initially. The shortlisted firms will be asked for presentation before the expert committee. The format for the submission of 'Financial Bids' will be sent to only shortlisted firms. The selected firms need to sign the Memorandum of Understanding with NIPER-G.

The applicant shall mention on the sealed envelope Firm's Name, Phone number & name of the contact person, and a line highlighting 'Techno-legal IP bid' and 'Do Not Open Before 1530 hours (3:30 PM) on 3<sup>rd</sup> January 2023'. The last date for receiving EOI is 3<sup>rd</sup> January 2023 before 1500 hours (3 PM), and the bids will be opened on the same day at 1530 hours (3:30 PM) in the presence of Authorised representatives of the Bidders.
